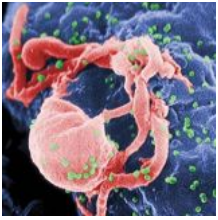

A screen recording of an SMS mobile device channel inviting me to a customer satisfaction survey and my response to this preliminary reopening of the door status request for client input in a survey process to which there has been a matter of ignoring my issues, topics, emails, LinkedIn public and InMail correspondences, and in several cases posted YouTube content videos in the name of Foothill Aids Project searchable at the YouTube Search prompt. This ignoring silence has been over 16 full months long since returning to the client contracted services of Foothill Aids Project in August of 2017. It is now December of 2018.

Survey consulting services provided by Marc Haupt/President of SST Nonprofit Services, a nonprofit organization that contracts with nonprofit organizations for various consulting services.

So far there has been only one single response from staff at Foothill Aids Project in writing. A response to a housing question sent via their Contact Us Form at their website domain [<http://fapinfo.org>]. This response email received was diffused of any logic, is purposefully designed and worded of deceptive practices and diverted from the true rational realism of what client is asking for as a paradigm shift of understanding and needs in my case management.

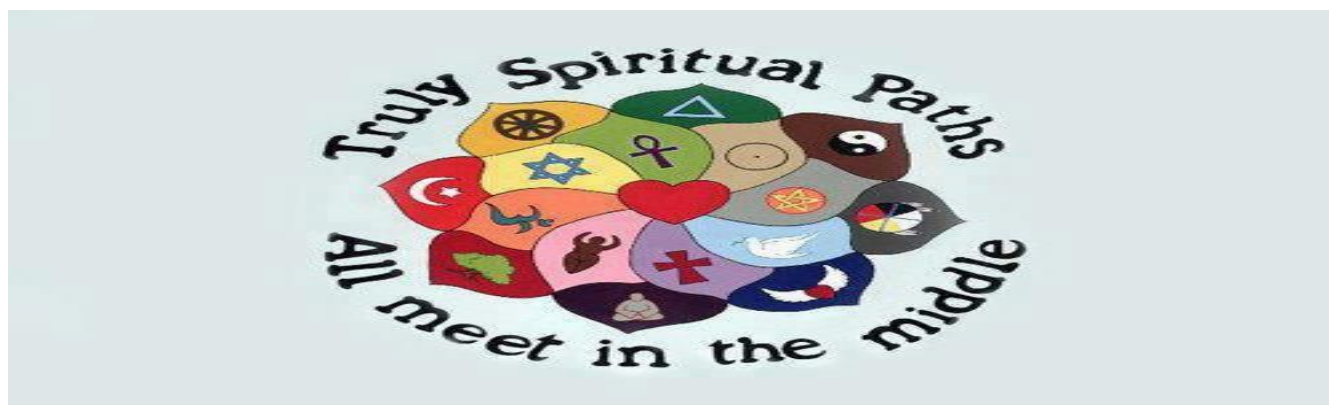
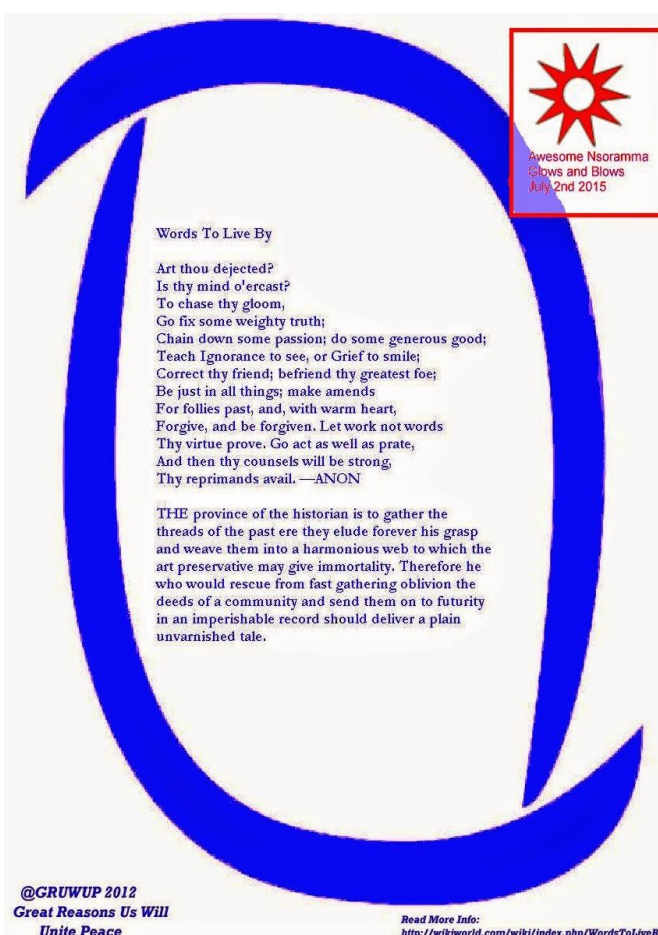
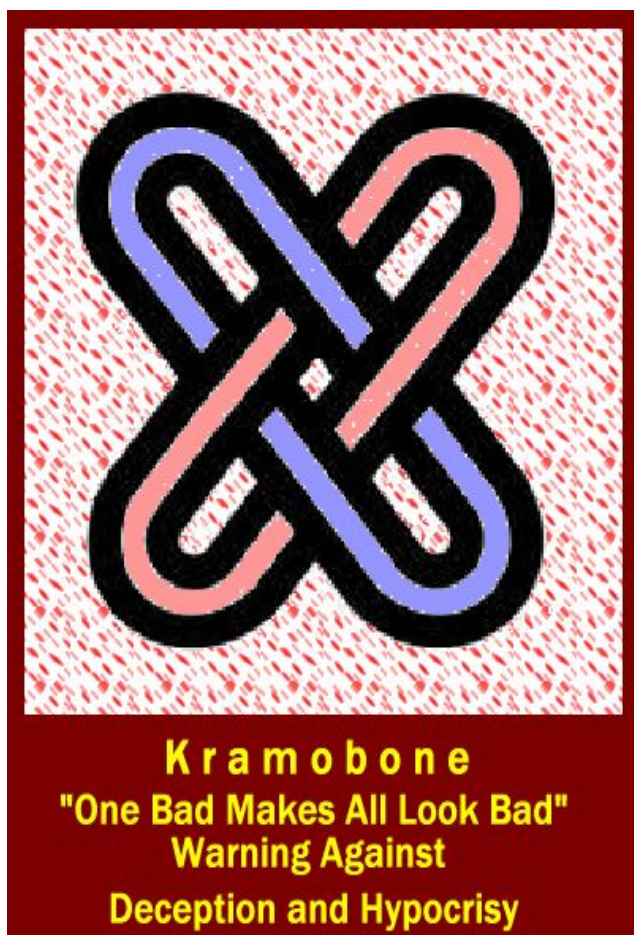
